#### Work Experience:

September 2004-Present: Rector, St. Martin's Church, Metairie, LA. Led the parish through recovery in the wake of Hurricane Katrina. Although we lost 25% of our parishioners overnight through re-location, we were a haven of stability and launching pad in the recovery effort for parishioners and others seeking to rebuild homes and lives. In 2009 we undertook a major capital campaign of nearly \$900,000 to reposition the front doors of our church to face Metairie Road and send a signal that we were engaging the neighborhood. During that time of national economic distress, we raised more than twice our pledge and plate income. A second capital campaign of \$750,000 was launched to celebrate our 75th Anniversary. Projects included a renovated chapel, purchase and relocation of a new organ in the church, and the commissioning of a large mosaic in the church narthex depicting the seminal story of our patron, Martin of Tours. Additionally, both campaigns addressed infrastructure needs such as HVAC and roofs. Through New Consecration Sunday Stewardship Education Program, we have increased our income four years running from \$450,000 to \$550,000. We have also instituted the Martin of

Tours Legacy Society to call attention to and build our endowment. Staff oversight of one priest associate, two full-time lay employees, and three part-time lay employees, and the Director of The Little School (a nursery and pre-k on our campus with sixty children and a staff of thirteen). Over the years I have supervised three deacons on staff, the last one retiring in May of 2015. Through COVID and Ida, we have remained a vibrant parish church in an unsteady world.

July 1998-August 2004. Vicar, Church of the Holy Comforter, New Orleans. Oversaw the sale of the former church, planning, and execution of the building of a new chapel to serve The University of New Orleans and Southern University in New Orleans as well as the local neighborhood. In this process we became Chapel of the Holy Comforter, and in addition to my duties as Vicar, I also served as the Episcopal Chaplain to UNO/SUNO. In partnership with the diocese, the worshipping community paid the costs of the ministry and facilities maintenance while the diocese covered the chaplain's compensation.

July 1996-June1998: Curate, St. Luke's Church, Baton Rouge, LA. Underwent a typical curacy in a Corporate/Resource Parish with a long history of training clergy. As the fourth full-time priest on the staff, I fulfilled a variety of roles, including outreach, working with youth, chaplain to St. Luke's Day School, as well as regular priestly duties of preaching, teaching, celebrating, and pastoral care.
