**Notice of Board Positions to be Filled by Election
at Annual Gathering 2026 and Request for Nominations**

February 6, 2026

In May 2026, the terms will end for the three elected, board positions listed and described below and new officers will need to be elected at the Annual Gathering of the Episcopal Church Women, Diocese of Louisiana, scheduled for **May 1-2, 2026**. At this Annual Gathering in St Matthew's, Houma, one delegate and one alternate will also be elected **for July 3-8, 2027 ECW Triennial in Phoenix, AZ**.

I. COMMUNICATIONS SECRETARY (2026-2029)

The communications secretary shall have oversight of information and communications for the Diocesan board during her term, such as: printed materials, electronic posts, website and social media. The communications secretary will be responsible for the board's email database, and any such communication duties as are delegated by the president.

II. RECORDING SECRETARY (2026-2029)

The recording secretary shall keep the minutes of all meetings. After each Annual Gathering, the recording secretary shall send a copy of the minutes to the president and to an appointed Reading Committee for review. Copies of the reviewed minutes shall be sent to members of the diocesan board and will be included in the packets of the next Annual Gathering. After each meeting of the diocesan board, copies of the minutes shall be sent to each member of the board. She shall also be responsible for obtaining and maintaining all stationery and supplies.

III. UTO DIOCESAN COORDINATOR (2026-2029)

The United Thank Offering coordinator shall endeavor to increase participation in the United Thank Offering and to deepen its meaning as an act of devotion. She shall receive and disperse contributions pursuant to the Diocesan board's procedures and direct this ministry in concert with the National United Thank Offering Handbook.

IV. DELEGATE AND ALTERNATE FOR 2027 TRIENNIAL IN PHOENIX, AZ

The Diocesan ECW funds a delegation for Triennial including the president, president-elect, United Thank Offering Coordinator and one delegate, who shall be elected at an Annual Gathering the year preceding the Triennial Meeting. One alternate shall be elected. If any elected delegate or alternate is unable to attend Triennial Meeting, the diocesan president with approval of the bishop, shall appoint another delegate in her place.
